A regular meeting of the City Council of the City of Valentine, Nebraska was held November 08, 2018 at 7:00 p.m. in the City Library Meeting Room, the same notice of meeting was given according to law. All of the proceedings hereafter shown were taken while the meeting was open to the public. A Public Information Council Agenda packet was available at the public information table. Notice of the Open Meetings Act was provided as required by law.

The Council and those in attendance recited the pledge of allegiance.

Vice-President of the Council Kalli Kieborz opened the meeting with the following Council members in attendance: Neil Wescott, Dave Otradovsky, Andrew Ward and Kyle Arganbright (7:07 p.m.). Also in attendance were City Manager Shane Siewert and Deanna Schmit, City Clerk, recorded the minutes.

Councilmember Wescott made the motion to approve the consent agenda items: #2a) Regular Library Board meeting minutes of October 22, 2018 #2b); Regular Cemetery Board meeting minutes of October 15, 2018 #2c Golf Board Meeting minutes of February 21, March 26, July 6, August 6, September 10, October 3, October 24, 2018; #3a) Regular Meeting of October 11, 2018; #4 September, 2018 Financial Reports; #5 October, 2018 Receipt Report; #6 October, 2018 Claims & Payroll. Councilmember Otradovsky seconded the motion. Voting Aye: Kieborz, Wescott, Otradovsky. Voting no: Ward. Motion carried three to one.

No action taken on the proposal for park equipment made from old tires.

Councilmember Kieborz made a motion, seconded by Arganbright, to approve the Street Superintendent/City Surveyor contracts for three years. Voting aye: Kieborz, Arganbright, Otradovsky. Voting no: Wescott, Ward. Motion carried three to two.

Councilmember Arganbright made a motion, seconded by Otradovsky, to approve the appointment of Jeff Wrage to the golf board for the remainder of Mike Danielski's term. Voting aye: Arganbright, Otradovsky, Kieborz, Ward. Voting no: Wescott. Motion carried four to one.

There being no further business before the council, Council Chairperson Arganbright declared the meeting adjourned at 7:13 p.m.
